Perfumed deodorizer cleaner / Concentrated product 1:20 WATER DILUTION

CHARACTERISTICS

<u>Product of high concentration.</u> Specific cleansing and deodorizing formulation that is suitable for application on any type of washable surface that requires thorough and total cleaning. Due to its high power with total cleaning, it is very effective in showers, saunas, public toilets, etc., and in those applications in which the maximum degree of cleaning is required. Thanks to its particular characteristics, it cleans even in difficult areas and floors.

HOW TO USE

<u>Do not to use without diluting.</u> In order to obtain the wished cleaner, dilute it in water at proportion 1:20. Example: 250 ml (1 glass) of product, to obtain 5 litres of cleaner preparation to use. Once realised the dilution and obtained the cleaner, it will be used of the habitual way: applying it diluted in water, normally 200 ml of product in a bucket of 10 l of water. Apply manually with mop, floorcloth or sponge or sprayed on the surface and let it dry. For difficult dirt the dose can be doubled. Don't apply it on food nor kitchens utensils. Don't apply it on surfaces where foodstuffs are manipulated, prepared, served or consumed.
