

DERMEX D-730

Antiseptic for healthy skin

CHARACTERISTICS

DERMEX D-730 is a bactericidal, levuricidal and virucidal gel dermatologically tested, of alcoholic formulation and quick evaporation, with 70 % of alcohol by volume. It cleans and sanitizes without rinsing with water. It is intended to be used in cases where it is required a high degree of hygiene and cleaning with water rinse is not possible.

UNE-EN 1040:2006, for the evaluation of bactericidal activity.

HOW TO USE

Use the pure product applying approximately 3 ml, spread and rub on the skin for 30 seconds until its evaporation and repeat again the application.

Substances that contribute to the classification: Etanol 42% w/w, Propan-2-ol 22% w/w, Aqua, Peg-15 cocamine, Propylene glycol, Glycerin and Carcomer.
