CHARACTERISTICS

It is a biocide detergent, specially formulated for contact cleaning and contact disinfecting all surfaces, machinery and equipment in the food industry. Effective against a broad spectrum of microorganisms, including Gram + and Gram-bacteria, and other related food industry.

It complies with Standard UNE-EN 13697:2002 for the evaluation of bactericidal and fungicidal activity of chemical disinfectants used in food, industrial, domestic and institutional areas.

Bactericidal activity diluted in water at 10 % at 5 minutes (*Listeria monocytogenes, Escherichia coli, Pseudonomas aeruginosa, Enterococcus hirae* and *Staphylococcus aureus*) and fungicidal activity diluted in water at 10 % at 15 minutes (*Aspergillus niger* and *Candida albicans*).

It complies with Standard UNE-EN 1650:2008+A1:2013, for evaluation of fungicidal activity of chemical disinfectants and antiseptics used in food, industrial, domestic and institutional areas, diluted in water at 5 % at 15 minutes (*Aspergillus niger* and *Candida albicans*).

HOW TO USE

<u>Air disinfection:</u> Spraying the diluted product in water. Application by specialized staff and it is recommended a security within 3 hours in the absence of people and food, being aired properly before entering the premises.

<u>Disinfection of contact:</u> For surfaces and equipment the diluted product is applied by spraying, cloth, sponge or mop manual washing. For foam application spray it with foam generating equipment, creating a layer that covers the surface, respecting contact times and rinse with plenty of water.
