CHARACTERISTICS

DETIAL D-800 is an energetic degreaser cleaner and disinfectant alkaline for industrial use of food products. Formulated to clean the dirt very inlaid. It cleans and disinfects controlling the proliferation of micro-organisms in the treated surfaces.

Indicated for nourishing industry: dairy products, meat, fishery, canning industry, drinks, etc., as well as in warehouses, food and waste containers, etc.

It complies with Standard UNE-EN 13697:2002 for the evaluation of bactericidal and fungicidal activity of chemical disinfectants used in food, industrial, domestic and institutional areas.

Bactericidal activity diluted in water at 10 % at 5 minutes (*Listeria monocytogenes*, *Escherichia coli*, *Pseudomonas aeruginosa*, *Enterococcus hirae* and *Staphylococcus aureus*).

Fungicidal activity diluted in water at 5 % at 15 minutes (*Aspergillus niger* and *Candida albicans*).

HOW TO USE

Clean before the application of the product. Apply manually with spray, scourer, brush, floorcloth, etc., or mechanically on foam projection equipment and let it act between 5-15 minutes. Due to its special composition of very alkaline pH, DETIAL D-800 does not have to be used in the cleaning of lead, chromium, aluminium, tin, zinc and their alloys. After the cleaning, rinse the surfaces with drinking water. Application by professional personnel.
