CHARACTERISTICS

Slow dissolve granulated chlorine for the disinfection and maintenance treatment of swimming pools water.

Microbiological properties on chemical disinfectants and antiseptics and standards that meet: Standard UNE-EN 1040:2006, for the evaluation of bactericidal activity.

HOW TO USE

<u>Initial treatment</u>: Chlorinate the pool at 3 g per m³ capacity of the pool the first day, dividing this amount equally among the pool skimmers, by putting the cleaner into operation.

Maintenance: Chlorinate daily and evening with 1,5 g per m³, continually adding to control the chlorine level, keeping it in their appropriate levels, between 0.6-1 ppm for private pools, and between 1-15 ppm in public pools. At very high temperatures, most bathers, storms, etc., increasing doses of chlorine in a

Rinse vigorously three times each package you use, pouring washing water to the pool.

Do not use in any case in the presence of bathers.
