CHARACTERISTICS

Bactericide and algaecide in tablets for the disinfection and maintenance treatment of swimming pools water.

Microbiological properties on chemical disinfectants and antiseptics and standards that meet: Standard UNE-EN 1040:2006, for the evaluation of bactericidal activity.

HOW TO USE

Initial treatment: Adjust the water pH between 7,2-7,6, and over-chlorination by entering 1 tablet per 25 m³ of water, with the debugger running.

Maintenance: Insert into the skimer, float, bag, etc. two tablets per 20 m³ of water and periodically check the chlorine level, which must be between 0, 6-1 ppm. Add tablets to maintain that chlorine level. The recommended doses are based on normal conditions. When large number of people, high temperatures, storms, must control the chlorine level and make complementary additions, if necessary.

Rinse vigorously three times each package you use, pouring washing water to the pool.
