

**LAVAPER ALC BOX+C**

Super concentrate BOX+C system**CHARACTERISTICS**

LAVAPER ALC BOX+C is used in textile washing, both in professional laundries and in hotels and residences, for cleaning dirty or very dirty clothes.

It is a highly concentrated alkaline detergent with high cleaning and degreasing power, which due to its special formulation allows the rapid saponification of oils and fats.

It contains sequestering agents that complex the calcium ions present in the water, avoiding the precipitation of salts in hard water, so it can be used in water of any hardness.

Do not use for washing delicate clothes.

**HOW TO USE IT**

It is used in the automatic washing of dirty and very dirty clothes. It is recommended to use together with LAVAPER TEN BOX+C or LAVAPER ENZ BOX+C. It can be dosed in both cold and hot water following the doses indicated in the following table, expressed in g/kg of dry clothes:

Type of dirt	Pre-wash	Wash (with pre-wash)	Wash (without pre-wash)
Slightly dirty	1,0 - 1,5 g	1,5 - 3,0 g	2,0 - 4,0 g
Dirty	1,5 - 2,0 g	3,0 - 4,5 g	4,0 - 6,0 g
Very dirty	2,0 - 2,5 g	4,5 - 6,0 g	6,0 - 8,0 g

In hard and very hard waters it is recommended to increase the doses by 30%. In tunnels washes they can be reduced by 10% due to the greater mechanical action in the wash.
