LAVAPER BLN BOX+C is used in textile washing, both in professional laundries and in hotels and residences, effectively removing stains, both on white and coloured clothes.

It is a special neutral bleach that does not punish fabrics and offers good results in mild conditions in the wash bath (pH 8.5-9.5) and at low temperatures (30-40°C).

Working in mild conditions lengthens the life of the garments, reduces energy consumption and reduces the number of rinses.

In addition, unlike other bleaches, it does not present an unpleasant odour or is aggressive for the skin, thus facilitating its handling.

This product has a good eco-toxicological profile, as it is non-toxic and inherently biodegradable.

HOW TO USE IT

It can be added in the washing phase or in the bleaching phase, following the doses indicated in the following table, expressed in g/kg of dry clothes:

Type of dirt	Wash	Bleaching
Slightly dirty	4 - 7 g	2 - 5 g
Dirty	7 - 10 g	5 - 8 g
Very dirty	10 - 16 g	8 - 10 g

Attention: It is recommended to control the pH of the wash, at pH 10 the effectiveness of the product decreases drastically.

To obtain the best results with blood stains, the garments should be rinsed with water before being put into the washing machine and before they come into contact with the product.

In hard and very hard waters it is recommended to increase the doses by 30%. In tunnels washes they can be reduced by 10% due to the greater mechanical action in the wash.
