CHARACTERISTICS

LUBACIN BIO-S is a powder formulation consisting of microorganisms, enzymes and nutrients that degrade organic matter (fat, protein, starch and cellulose) in drains, septic tanks and grease traps in the kitchens of hotel and catering industry.

The use of LUBACIN BIO-S is specifically indicated for preventive treatment of tubes, facilitating the proper functioning of the systems for the disposal of grease traps, maintaining the biological balance and controlling odours.

Its use is exempt of any danger, being indispensable in kitchens, catering and hospitality industry.

HOW TO USE

Insert, without opening, a 200 g bag of LUBACIN BIO-S in a bucket preferably with warm water (20° to 40° C). Wait 10 minutes and shake the mixture until the product is fully diluted, pouring a small amount into each of the establishment's drains.

Treatments should be done at the end of the working day and before closing the establishment in order to allow longer working time without interference with other products.

DOSAGE: The dosage to will always depend on the severity of the problem, taking as a guide the following indications.

Starting dose: Two bags of LUBACIN BIO-S.

Maintenance dose: One bag of LUBACIN BIO-S every week.

Siphons and pipes: To avoid blockages, obstructions and bad odours, dose a bag of LUBACIN BIO-S every week, according to the diameter and length of the drain.

Septic tanks: For a better liquefaction of the organic remains of the pit and to facilitate its emptying, the following doses are recommended:

- Three bags of LUBACIN BIO-S as initial seed dose per m³.
- One bag every 15 days as maintenance for every m3.
