

**LUBACIN H-DA**  
Bactericidal and virucidal of fast  
evaporation

### CHARACTERISTICS

Contact disinfectant with rapid evaporation where high hygiene quality is required, applicable in the public or private sphere, the food industry and in collective catering.

Formulated with a mixture of alcohols and quaternary ammonium, it can be applied in breaks of production processes to avoid cross contamination.

Microbiological properties on chemical disinfectants and standards that meet:

Standard UNE-EN 13697:2015 for the evaluation of bactericidal activity of chemical disinfectants used in food, industrial, domestic and institutional areas.

Bactericidal activity at 5 minutes (*Pseudomonas aeruginosa*, *Staphylococcus aureus*, *Enterococcus hirae*, *Escherichia coli*, *Salmonella typhimorium* and *Listeria monocytogenes*).

UNE-EN 14476:2014+A2:2019 standard for the virucidal activity of chemical disinfectants and antiseptics used in the medical area.

Virucidal activity after 2 minutes (Polivirus type 1, Adenovirus type 5 and murine Norovirus).

### HOW TO USE

Use pure, after a thorough cleaning by spraying on surfaces and equipment, immersion of utensils in a bath, or recirculation of the product through the circuits to be disinfected, leaving to act for 5 minutes for bacteria or 2 minutes for viruses, allowing to dry or using a cloth or cellulose to remove the dirt.

Always apply in the absence of food or feed and avoid cleaning hot ovens with the product since it is flammable.

After applying the product, rinse the surfaces that will be in contact with food with drinking water.

Use by the general public and application by professional staff.
